Committee

 The committee reviewed the updated document and the anticipated dates for first reading of previously reviewed policies.
- b. Remaining required policies to be reviewed
 - i. Policy 8130.2 Workplace Violence Prevention
 - 1. With associated training, policy statements, and evaluations
 - ii. Policy 9260 Conditional Appointment and Emergency Conditional Appointment Student Safety
 - iii. Policy 6700 Purchasing

 Mr. Slentz updated the committee on the projected timeline for completion of these required policies with policy 8130.2 being the focus of the current meeting.
- c. Code of Conduct review

Mr. Slentz updated the committee on the progress that has been made on the review of the Code of Conduct and the anticipated next steps. The committee requested that Mr. Slentz share the policy revisions to date so as to allow the committee the opportunity to discuss changes that are of concern and/or unclear.
